### WECA Meetings in Review: January – March

In January, WECA donated \$50 in memory of Paul Brooks to the Christ Episcopal Church. We received a thank you from his wife, Ginger, Historic Tour docent.

Historic Tours - In February, Marge Hull, Janette Jones, and Jane Devlin prepared for the annual Historic Tour Docents' Tea, which was held at the Mill Street Inn this year. Marge has also met with the docents, scheduled docents for the Saturday tours, ordered new signs that point the way to the tour's beginning at Long Wharf, and advertised the opening day of tour season – April 2.

Wallace Office Building – Jane Devlin continues to work with several grant agencies to move closer to construction day. Construction plans were sent for review to the Easement Program Committee at Maryland Historical Trust (MHT) on March 8th. Invoices for restoration to date are being submitted to MHT for review and acceptance towards grant award match and a general contractor bid package is being prepared to be submitted to MHT for review. Advertising will follow approval of the package by MHT.

WECA wrote a letter to the Cambridge City Council and City Manager in support of the High Street trees being preserved by putting electric lines underground.



## Well Maintained Properties are a Win-Win for All

The City of Cambridge legislated Code Enforcement to ensure that all City residents have the opportunity to create a safe, healthy, satisfying quality of life. These codes (rules) set the minimum standards acceptable for structures, operation, and land use. Fortunately, the majority of properties in the West End are in compliance with City Code, but the impact of the 8% of the properties that are not is dramatic. Some violations of the code are minimal, and made by people that are honestly unaware of the codes, and easily rectified. However, there are some major eyesores created by people who refuse to comply, even when they are aware of the codes. Not only are they diminishing the value of their property, they are negatively impacting the whole neighborhood.

# Abandonment and Discontinuence of Nonconforming Use of Structure Regulation Still in Force

Within our community, a number of structures that were originally constructed as single family homes have been subdivided to create multifamily housing. This activity of subdivision is no longer permitted. Under certain circumstances, there is a regulatory mechanism within the city code to mandate the return to a single family structure. If the structure has been vacant and unoccupied for an extended period of time the City disallows the continuance of the nonconforming use of the structure pursuant to Section 2.4.2 Nonconforming Lots, Structures and Uses regulations of the Unified Development Code (UDC).
